



## **Donating Cryptocurrency**

Thank you for your interest in making a gift of cryptocurrency for the benefit of the ministries you support. This handout will walk you through the gifting process.

- Step 1:** Complete the enclosed cryptocurrency gift information form and return it to Barnabas Foundation.
- Step 2:** We will review your completed form, and check it against the OFAC (Office of Foreign Assets Control) Sanctions list.
- Step 3:** We will provide you our wallet ID for the transfer, along with confirmation of acceptance.
- Step 4:** Contact our office ([gifts@BarnabasFoundation.com](mailto:gifts@BarnabasFoundation.com)) when the transfer has been made.
- Step 5:** Upon receipt, Barnabas Foundation will immediately liquidate it and provide you a charitable receipt for your tax records stating the amount received on liquidation.

### **Important Considerations:**

- To be eligible for a full fair market charitable deduction, you must have held the cryptocurrency for at least one year. If held less than a year the charitable deduction is limited to the lesser of the original cost or the present value.
- Per IRS regulations, for donations of cryptocurrency over \$500, you must complete IRS Form 8283, *Noncash Charitable Contributions*, and include it with your tax return. For donations of cryptocurrency over \$5,000, you must also complete Section B of Form 8283. You are responsible for obtaining an appraisal from a qualified appraiser to substantiate the gift for charitable deduction purposes. Upon request, we will provide you with contact information for potential appraisers. The cost of an appraisal may range from \$120 to \$600, depending on the appraiser.
